WHEREAS TCIL has floated Tender no.TCIL/69/Maharashtra-DMU/ TPQAA /2024/01 issued on 22.07.2024 for Selection of Agency for Third Party Quality Assurance Agency (TPQAA) for Shifting of Overhead Power line to Underground Power Cable & other associated works in Palghar, Ratnagiri and Thane District of Maharashtra on GEM . GEM Tender ID: GEM/2024/B/5190773.

WHEREAS M/s. Adarsh Consultancy had submitted bid dated 31.01.2025 on GEM portal.

WHEREAS it came to the notice of TCIL that M/s. Adarsh Consultancy had submitted following false/forged documents along with the bid:

- Letter no. KSEB/TPA/2022/735 dated 19.06.2022 issued by Kerala State Electricity board (KESL).
- Letter no.eval/2021/632 dated 12/10/2021 issued by Meghalya Power Generation Corporation Ltd (MePGCL).
- Letter no.GHT/TP/2024/305 dated 10.05.2024 issued by Assam Power Distribution Company Ltd (APDCL).
- Letter no.JBVNL/2021/301-305 dated 13.01.2021 issued by Jharkhand Bijli Vitram Nigan Limited. (JBVNL) to meet the eligibility criteria for similar works.

Upon verification by TCIL, the respective organizations have confirmed that they have not issued the said letters.

WHEREAS TCIL had issued a Show Cause notice to M/s Adarsh Consultancy as referred above at Sr No. 3 to clarify why an action should not be taken against it as per clause 1.14 of tender for submission of forged documents by you, for securing business with TCIL.

WHEREAS TCIL has not received any response from M/s Adarsh Consultancy against the said show cause notice .

Hence, it is apparent that the said documents were submitted with a malafide intention to secure the contract based on forged and fraudulent documents. In view of above, TCIL is constrained to take action as per the terms and condition of Tender based on the available records and documents with it.


After review of the case under extant guidelines of TCIL and under Clause No 1.2 (Undertaking of Genuineness), No.1.14 (Submission of forged document) and Clause 2.22 B h (Additional condition for debarment) of the Tender Document, it is hereby informed that the bid submitted by M/s. Adarsh Consultancy dated 31.01.2025 against the said tender stands rejected.

Further, TCIL has decided to debar M/s Adarsh Consultancy as per clause 1.2 and 1.14 of tender under reference, for a period of 2 (two) years from the date of issue of this order i.e 01.07.2025 for doing any business across TCIL for all items/works/services.

Accordingly, M/s Adarsh Consultancy is hereby debarred from participation in TCIL tender (s) / EOI (s) for a period of 2 years from date of issue of this order. Existing offers, if any, submitted by M/s Adarsh Consultancy will not be considered and shall be summarily rejected.

The above action is without prejudice to the rights of TCIL under the contract and/or law.
