WHEREAS TCIL has floated Tender no. TCIL/69/Maharashtra-DMU/ Palghar /2025/12 Dated: 10.02.2025 for Selection of Agency for Shifting of Overhead Power line to Underground Power Cable & other associated works under Disaster Management, Relief & Rehabilitation, Maharashtra in Palghar District of Maharashtra.

WHEREAS M/s. R.R.Enterprises had submitted bid dated 01.03.2025 in Consortium with M/s Rajesh Power Services Limited.

WHEREAS M/s. R.R. Enterprises had submitted Work completion certificate outward no. 6308/2-2024-25 dated 30.01.2025 purported to be issued by Municipal Council Parli Vajinath.

Upon verification of the said certificate by TCIL, Chief Officer Municipal Council Parli Vajinath had confirmed that they had not issued the said letter.

WHEREAS TCIL had issued a Show Cause notice to M/s R.R. Enterprises as referred above at Sr No. iii) to clarify why an action should not be taken against it as per clause 1.14 of tender for submission of forged documents, for securing business with TCIL.

WHEREAS in response to the said show cause notice, M/s R.R. Enterprises submitted outword no. 868/2025-26 dated 13.05.2025 purportedly issued by Chief Officer Municipal Council Parli Vajinath in their defence.

WHEREAS upon verification of the said letter dated 13.05.2025 by TCIL, Chief Officer Municipal Council Parli Vajinath had confirmed that they had not issued the letter dated 13.05.2025.

Hence, it is apparent that M/s. R.R. Enterprises not only submitted false and forged documents in its bid with a malafide intention to secure the contract, but when such falsity was observed by TCIL and an opportunity to explain the situation was provide to M/s. R.R. Enterprises, it chose to submit another forged confirmation letter in furtherance of its malafide intentions with a view to defraud TCIL based on such forged and fraudulent documents.

In view of above, TCIL is constrained to take action as per the terms and condition of Tender based on the above facts and available records and documents with it.

After review of the case under extant guidelines of TCIL and under Clause No 1.3 (Undertaking of Genuineness), No.1.14 (Submission of forged document) and Clause 2.23 B h (Additional condition for debarment) of the Tender Document, it is hereby informed that the bid submitted by M/s. RR Enterprises in consortium with M/s Rajesh Power Services Limited dated 01.03.2025 against the said tender stands rejected.

Further, TCIL has decided to forfeit security deposited /EMD of Rs. 30600000/- and to debar M/s R.R. Enterprises as per clause 1.3 and 1.14 of Section 1 of the tender under reference, for a period of 2 (two) years from the date of issue of this order i.e 04.07.2025 for doing any business across TCIL for all items/works/services.

Accordingly, Bid Security /EMD of Rs. 30600000/- has been processed for forfeiture and M/s. R.R Enterprises is hereby debarred from participation in TCIL tender (s) / EOI (s) for a period of 2 years from date of issue of this order. Existing offers, if any, submitted by M/s. R.R. Enterprises will not be considered and shall be summarily rejected.

The above action is without prejudice to the other rights of TCIL under the contract and/or law.
