After review of the case under extant guidelines of TCIL and under clause 2.24 of the Tender, it is hereby informed that

1. The bid dated 05.10.2021 submitted against the said tender stands rejected.
2. The competent authority of TCIL has imposed a ban on M/s Lavanya Construction Pvt. Ltd., as per clause 2.24 of tender under reference for a period of five (05) years from the date of issue of banning order i.e. 20.04.2022 for participating in future bidding processes of TCIL for all items/works/services.
3. Further, M/s Lavanya Construction Pvt. Ltd. is liable to make payments to TCIL for the damages incurred to TCIL and expenses incurred by TCIL due to the conduct of M/s Lavanya Construction.

Accordingly, M/s Lavanya Construction Pvt. Ltd. is hereby debarred/banned for participation in TCIL tender/EOI for a period of 5 years from the date of issue of this order. Existing offers, if any, submitted M/s Lavanya Construction Pvt. Ltd. will not be considered and the same will be summarily rejected.

The above action is without prejudice to the rights of TCIL under the contract and/or law and TCIL reserves the right to claim for damages incurred during this process once they are quantified.
