Dear Sir,

This has reference to TCIL's above referred TCIL's Tender No. TCIL/15/1800/I/18-MM/18E, Dated: 14.12.2018 for "Appointment of Travel Agent", wherein you had submitted Bid for this Tender under reference 1.

TCIL had issued show cause notice to M/s Sharp Travels (India) Limited vide above reference no. 3 to clarify why action should not be taken against you, in connection with submission of false documents by you for securing business with TCIL.

After review of the case by competent authority and under extant guidelines of TCIL, it is hereby informed that the competent authority of TCIL has imposed a ban on M/s Sharp Travels (India) Limited for doing any business across TCIL for all items/works/services for a period of 3 years from the date of issue of ban order i.e. 27-07-2021.

Accordingly, M/s Sharp Travels (India) Limited will not be eligible for participating in any tender from TCIL. Existing offers, if any, submitted by M/s Sharp Travels (India) Limited will not be considered and the same will be summarily rejected. Existing contracts, if any, entered with M/s Sharp Travels (India) Limited shall be short closed by TCIL.
