Sub: Rejection of Bid and Banning of Business Dealing with M/s Tana Hali Constructions & Co – in Tender No TCIL/75/59/I/21/CIVIL-MM/39E Dated: 25.03.2021 for “Construction of EMRS (Eklavya Model Residential School) at Itanagar in Arunachal Pradesh.

Dear Sir/Madam,

WHEREAS TCIL had floated tender no. TCIL/75/59/I/21/CIVIL-MM/39E Dated: 25.03.2021 for “Construction of EMRS (Eklavya Model Residential School) at Itanagar in Arunachal Pradesh, wherein you had submitted your bid dated 14.04.2021.

WHEREAS it came to the notice of TCIL that you had submitted false documents pertaining to following project alongwith your bid:

A) Name of the Work: Construction of Non Residential Bldg. for Rajiv Gandhi University, Rono Hills Doimukh, (Sh: Construction of i)- Social Science Main Faculty Building, ii)-Main faculty building for mass communication Department, iii)- Main faculty building for Education department, iv)- Research Scholarship Hostel for Girls, v) Auditorium Hall for Rajiv Gandhi University, Rono Hills Doimukh.

i) Work Completion Certificate letter No. AU/Dee-12/2013-2014/014 Date RGU, the 12th Dec, 2016

ii) Work Order No. :EE/Dec/RGU-89/2013-14/24 Date RGU, the 24th March, 2014

WHEREAS TCIL had issued a Show Cause notice to **M/s Tana Hali Constructions & Co** as referred above at Sr No. 3 to clarify why an action should not be taken against you as per clause 2.9 of tender in connection with submission of forged LOA and completion certificate by you for securing business with TCIL

However, on request of M/s **M/s Tana Hali Constructions & Co**, the documents/work experience certificates were once again got verified from the client (Rajiv Gandhi University, Rono Hills Doimukh). The client had not endorsed the certificates submitted by M/s Tana Halli Construction & Co, as a part of bid. However, the client has endorsed 3 different projects executed by M/s Tana Halli Construction & Co. but not the one for which experience certificates were submitted. These three projects does not qualify M/s Tana Halli Construction & Co for eligibility.

Hence, it is implied that the said documents were submitted with a malafide intention to secure the contract based on forged and fraudulent documents. In view of above, TCIL is left with no other alternative but to take action as per the terms of Tender and Integrity Pact based on the available records and documents with it

After review of the case under extant guidelines of TCIL and under Clause No 1.7 (Certification of Genuineness), No.2.9 (Debarment/Blacklisting), Clause 2.6 (d) (Other conditions of bidding process) of the Tender Document and Clause No. 5 of the Integrity Pact (Sanctions for Violations), , it is hereby informed that:


- (i) **M/s Tana Hali Constructions & Co** is disqualified from evaluation process in the said tender and the bid dated 14.04.2021 submitted against the said tender stands rejected
- (ii) The Security Deposit/EMD of Rs. 2,50,000/- Submitted by **M/s Tana Hali Constructions & Co** is forfeited.

TCIL has imposed a ban on **M/s Tana Hali Constructions & Co** as per clause 2.9 of tender under reference, for a period of five (05) years from the date of issue of banning order i.e. 27.06.2022, for doing any business across TCIL for all items/works/services.

Accordingly, **M/s Tana Hali Constructions & Co** is hereby debarred/ banned for participation in TCIL tender (s) / EOI (s) for a period of 5 years from date of issue of this order. Existing offers, if any, submitted by **M/s Tana Hali Constructions & Co** will not be considered and shall be summarily rejected.

The above action is without prejudice to the rights of TCIL under the contract and/or law.
