**CIRCULAR**

**Subject: "Modification of Integrity Pact Format" & Increase in "Threshold value of Integrity Pact" reg.**

TCIL Board, in its 235<sup>th</sup> Meeting, has accorded approval for the following recommendations of the IEMs proposed during their 26<sup>th</sup> IEM Meet:

- (i) Adaptation of the modified IP Format
- (ii) To increase the threshold value of IP from Rs. 1Crore to Rs. 5 Crores

Accordingly, all concerned are hereby informed to ensure the following:

- (i) The enclosed modified IP format shall be used in the tender (RFO/EOI/RFP/RFQ/any tender) for signing of Integrity Pact from immediate effect.

However, in case there is any difficulty in getting the IP Document signed, such cases shall be brought to the notice of CMD through their respective HODs with a request for relaxation. The decision of the CMD shall be communicated to CVO by the concerned officer.

- (ii) The IP shall form part of preliminary qualification in all tenders (RFO/EOI/RFP/RFQ/any tender).
- (iii) The threshold value for signing of Integrity Pact has been increased from Rupees 1 Crore to Rupees 5 Crores with immediate effect.
- (iv) Further, the concerned Divisional head shall ensure that the soft copy of the published tenders (RFO/EOI/RFP/RFQ/any tender) whose estimated value is above threshold value shall be forwarded for information to the IEMs & the CVO.
