The work involve functionality of kitchen bidder is required to quote for functionality of item as per site condition. Bidder is to quote lumpsum item for functionality of oil and grease chamber and its connection to existing sewer line inside the building. If any item is required shall be provided by the bidder in the quote and no additional item will be paid extra. Bidder is advised to visit the site.
