1.0 CONTRACT DOCUMENTATION

2.0 COVENANT TO PERFORM

In consideration for payment by the Company of the Contract Price, pursuant to the terms of the Contract, the Contractor undertakes to carry out the Works and perform its other obligations to the standards set out in and otherwise in accordance with the provisions of the Contract.

3.0 CONTRACT PRICE
